



WARRIOR WOMAN PROJECT® RETREAT CANCELLATION POLICY PAYMENT POLICY

To secure the reservation a minimum of £100 deposit must be paid with the outstanding balance paid within the date agreed for any Early Bird offers. If booking within 21 days of the start date the full amount will be due.

RETREAT CANCELLATIONS

It is your responsibility to read and understand our cancellation policy before making a reservation.

Naturally, no one books with the intention of cancelling or postponing their retreat, but unexpected things do happen, so please purchase travel cancellation insurance once you have made your reservation.

DEFINITIONS

"Cancellation" is defined as not attending your scheduled retreat, including postponing or rescheduling.

"You" refers to the guest booking a retreat.

"We" refers to Warrior Woman Project®.

TRAVEL AND CANCELLATION INSURANCE

To join the retreat you must have travel insurance. Please be sure that your insurance policy covers you for all relevant activities you will be engaging upon on your retreat & TRIP CANCELLATION.

Depending on the policy and conditions, travel cancellation insurance will pay for some or all cancellation fees.

With most agencies, insurance must be purchased within 14 days of making your reservation.



GUEST CANCELLATION POLICY

If you cancel your trip, Warrior Woman Project® does not offer refunds for any reason. A portion of your payment may be used as credit for another retreat to be taken within two years of your original retreat date. We will gladly transfer your credit to another guest.

Depending on when you cancel, cancellation penalties may apply.

Fees are determined by the following schedule:

- If you cancel more than 90 days before your retreat start date, 100% of your payment may be applied to another retreat.
- If you cancel 60 – 89 days before your retreat start date, 75% of your payment may be applied to another retreat. You will forfeit 25% of the price of your retreat.
- If you cancel 15 – 59 days before your retreat start date, 40% of your payment may be applied to another retreat. You will forfeit 60% of the price of your retreat.
- If you cancel 14 days or less before your retreat start date, you will forfeit your entire payment.

Exceptions to our policy cannot be made for any reason. We do not offer credit for a guest arriving late or leaving early. You must submit your signed Participant Agreement form within one week of booking or 90 days prior to retreat start date, whichever comes first. Guests who fail to do so may be subject to an automatic cancellation and the above policy will apply.

WARRIOR WOMAN PROJECT® CANCELLATION POLICY

We do not wish or expect to cancel a retreat, however if Warrior Woman Project® must cancel a booked retreat date for any reason, you may transfer your full retreat payment to another retreat, or you may request a refund of your payment to us, constituting a full settlement.

Warrior Woman Project® is not responsible for your expenses incurred in preparation for any cancelled retreat, such as airline tickets, loss of work, and/or other costs associated with preparing for your trip.
